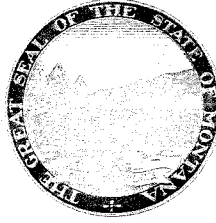

Dear Mr. Allison:

We received your Affidavit with the caption as "All Pending Petitioners vs. Brotherhood Mutual Insurance Company" and the cause number as "All Pending Actions." For clerical purposes, we ask that you file an Affidavit in each of the common fund matters with the correct caption on each form, taking into account the following.

No summonses have been issued in the *Stavenjord* and *Wild* matters, so it is not necessary to file an Affidavit in these two cases at this time. Brotherhood Mutual was not named in the *Hiatt* and the *Rausch* matters, and Brotherhood Mutual was dismissed from the *Reesor* matter on June 27, 2005. A Notice of Opportunity to Appear and Intervene was filed in *Satterlee*, but not a summons. We have received your Affidavit in the *Schmill* matter. Therefore, you only need to file an Affidavit in the *Flynn* case. To assist you in setting out the caption, the following is the link to the summons on our website.


