

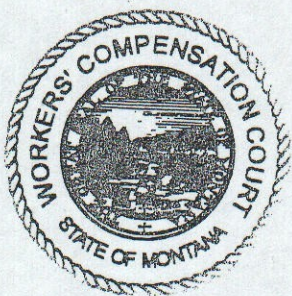


COMES NOW the above-named parties through their attorneys of record and stipulate to entry of judgment as follows.
