¶1 On January 10, 2005, the Court mailed a Summons to each of you named in this Second Summons. In that first Summons, the Court ordered each of you to file a response providing enumerated information. A copy of the first Summons is attached hereto.

¶2 Each of you named in this Second Summons failed to file a response as ordered. This Second Summons is therefore issued and shall be served in accordance with the Montana Rules of Civil Procedure and statutory provisions governing service of process.

¶3 As set forth in the first Summons, each of you are directed to withhold the attorney fees claimed in the Lien Notice previously sent to you. Another copy of the lien is attached.

¶4 Further, each of you is **ordered** to file a written response to this Second Summons setting forth all of the information required in paragraph 4 of the first Summons. If you are unable to provide the information required by that paragraph, object to furnishing the information, or wish to provide the information by other means, then you must file a response in accordance with paragraph 5 of the first Summons.

¶5 Your response must be mailed to the Workers' Compensation Court, P.O. Box 537, Helena, MT 59624-0537, or sent via Federal Express or other courier to the Court at its offices on 1625 11th Avenue, Helena, MT 59601, and **received** by the Court no later than **[date]**. Do not serve copies of your responses on the parties or their attorneys as the Court will be responsible for any necessary service.

¶6 **Finally, you are notified that this Second Summons will be enforced by the Court through whatever means are available to it, including but not limited to its powers of contempt.**
