Dear Mr. Booth:

As a result of a decision by the Montana Supreme Court on September 5, 2002, in Rausch, et al., Petitioners, v. Montana State Fund, Respondent/Insurer, WCC 9907-8274R1, petitioners established the right of permanently totally disabled workers' compensation claimants to receive an impairment award. You have been identified as a claimant who has received such an award, pursuant to the Supreme Court's decision.

As the petitioners in this case established the legal precedent for the immediate payment of the impairment awards to permanently totally disabled claimants, the Montana Supreme Court has determined that attorneys' fees are payable from the impairment awards obtained for claimants who suffered work injuries from the period of July 1, 1991, to September 5, 2002. The petitioners in *Rausch*, *et al.* were represented by Monte Beck, Stephen Roberts and myself. We are the common fund attorneys.

In recognition of this decision by the Montana Supreme Court, your workers' compensation insurer (MACo), withheld 15% of your impairment award in order to pay the attorneys' fees incurred by Petitioners. State workers' compensation law allows 25% for attorneys' fees. As the common fund attorneys, however, we have agreed that attorneys fees in the common fund cases be fixed at the rate of 15% of the impairment awards, therefore, a common fund

attorneys' fee in the amount of \$897.75 (15%) was withheld from your impairment award of \$5,985.00.

If you object to the amount of common fund attorneys' fees that were withheld from your impairment award, you must file a written objection to payment of the common fund attorneys within twenty (20) days of your receipt of this notice. (See copy of Judge Shea's March 30, 2010, Order, enclosed)

If you object, you are to send a written statement supporting your objection within 20 days of receipt of this notice to both my office and the Workers' Compensation Court at the following addresses:
