STIPULATION

The parties hereto, by counsel, stipulate and agree as follows:


1. This Stipulation shall supplement the Settlement Stipulation of the parties filed with the Court on September 22, 2008.
2. The parties have agreed to modify their Settlement Agreement and Settlement Stipulation, to fully conform to the Court's Order approving the settlement. To the extent there is any inconsistency between the Settlement Agreement and/or the Settlement Stipulation and the Court's Order approving the settlement, the parties stipulate and agree the Settlement Agreement and Settlement Stipulation are hereby deemed amended to comply with the Court's Order.
3. For purposes of clarification, the parties agree that the reference to "Claimants" in the Settlement Agreement refers to the counsel specifically referenced

therein. As used in the Settlement Stipulation, "Claimants" references the same counsel, whereas "claimants" is meant to include those with potential entitlement to Stavenjord benefits.




