¶2 I, Gary H. Shapiro (NAME), am the Executive Vice-Pres. & General Counsel (POSITION) of Euler American Credit Indemnity Co. (NAME OF INSURER OR SELF-INSURER).

¶3 In my capacity as E.V.P. - General Counsel (POSITION) of Euler American Credit Ind. Co. (NAME OF INSURER OR SELF-INSURER), I am authorized to make the statements set forth in this affidavit on behalf of Euler Amer. Credit Ind. Co. (NAME OF INSURER OR SELF-INSURER) and to bind Euler Amer Credit Ind. Co. (NAME OF INSURER OR SELF-INSURER) by these statements.

¶4 After a review of our records, I swear under oath that Euler American Credit Indemnity Co. (NAME OF INSURER OR SELF-INSURER) should be dismissed from the above-entitled action for any or all of the following reasons (check any or all that apply):

¶15 I understand that the Montana Workers' Compensation Court may allow a period of up to 90 days from the date of filing this affidavit within which Petitioner's counsel may conduct discovery and investigation for the limited purpose of proving or disproving the foregoing statement(s) made by me on behalf of Euler Amer. Cr. Ind. Co (NAME OF INSURER OR SELF-INSURER). After such 90 days, if no objection is lodged by the Petitioner's counsel, the Court will dismiss the insurer/self-insurer from this action based on the sworn statements made by me in this affidavit.
