4. After a review of our records, I swear under oath that Metropolitan General Insurance Company should be dismissed from the above-entitled action for any or all of the following reasons (check any or all that apply):

After such 90 days, if no objection is lodged by the Petitioner's counsel, the Court will dismiss the insurer/self-insurer from this action based on the sworn statements made by me in this affidavit.

6. I declare under penalty of perjury that the foregoing is correct.


