¶6 I declare under penalty of perjury that the foregoing is correct.

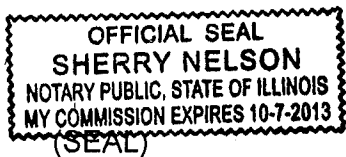
