ConAgra Foods, Inc. has no claimants meeting the Court's criteria in this matter as set forth in the summons and Flynn III, 2011 MT 300.





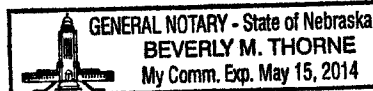
