ORDER INCORPORATING MINUTE ENTRY

¶ 1 During a telephonic hearing, the Court discussed Petitioner's Motion for Order to Show Cause against Respondent Insurers, as set forth in Minute Book Hearing No. 4671. This Order formalizes the Court's rulings.

¶ 7 Golden Sunlight Mines Inc. – A status update is due **Friday, September 30, 2016;** the Affidavit or other response is due **Monday, October 31, 2016.**

¶ 8 Northwest Healthcare Corp. – The Affidavit was filed on July 1, 2016, which triggered the discovery period – no deadline ordered.

¶ 9 Northwestern Energy – The Affidavit or other response is due **Friday, September 30, 2016**.

¶ 10 Plum Creek Mgmt Co. LP, Plum Creek Timber Co. Inc., Plum Creek Timber Co. LP – The Affidavits or other responses are due **Monday, October 31, 2016**.

¶ 11 Rosauers Supermarkets Inc. – The Affidavit or other response is due **Friday, September 30, 2016**.

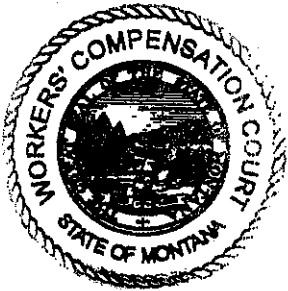
