¶ 8 J H Kelly LLC – Petitioner will be filing a request to dismiss in the near future – no deadline ordered.

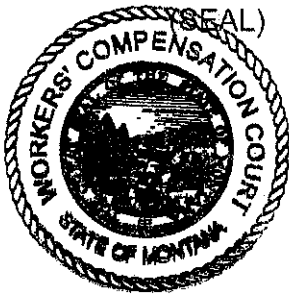
¶ 9 Louisiana Pacific Corp. – The Affidavit or other response is due **Friday, September 30, 2016.**
